Peninsula Clean Energy Now For Businesses

Peninsula Clean Energy (PCE) - San Mateo County's electricity provider - offers electricity with at least 50% renewable energy content from sources like wind and solar power. Burlingame electricity customers will automatically be enrolled into PCE over two phases. The first phase occurred in October 2016 and the second will be in April 2017. PCE offers two rates for customers: ECOplus is

the default rate with 50% renewable energy content; and ECO100 is the opt-up option for 100% renewable energy. The ECOplus option costs about 5% less than the existing PG&E rate while the ECO100 option costs about 5% more.
